Introduction

The Department of Floriculture, Gardens & Parks, came into existence in the year 1969 as an independent entity in Jammu & Kashmir. The Directorate of Floriculture Kashmir is located at Emporium Garden Srinagar. Presently, Directorate of Floriculture is maintaining **211** Gardens, Parks and lawns spreading over an area of **8**629.5 Kanals. This includes world famous Tulip Garden, eight heritage Mughal Gardens viz Nishat, Shalimar, PariMahal, Cheshmashahi, Jarokhabagh (Ganderbal),

Verinag (Anantnag) ,Achabal (Anantnag) and Dara Shikow (Anantnag) and two Botanical Gardens (NMBG Cheshmashahi and Kokernag, Anantnag). Besides important gardens and parks, the Department is maintaining lawns at three important installations viz, **Raj Bhawan**,

New Secretariat, High Court and office-cum-residential lawns of VVIPs and VIPs.

The Gardens and Parks are important source of tourist inflow particularly in respect of Heritage Mughal Gardens where lakhs of tourists (domestic and international) visit every season/year. The garden tourism is not only important source of attraction for tourists but also serves as an important source of research and development for plant/environmental Scientists, landscapers as well as Botanists. The Gardens/parks are maintained professionally and efficiently by the Department. The maintenance of the gardens has been acclaimed and appreciated worldwide. Tulip Garden was adjudged as second and fourth best Tulip destination of the world by World Tulip Summit Society in the year 2015 and 2017 respectively and Mughal Gardens of Shalimar, Nishat, and Achabal were included in the tentative heritage list of UNESCO's heritage sites.

Vision

Recognizing the fact that Garden Tourism is an important sector for socio economic upliftment: the need for promoting this sector by upgradation and maintenance of Gardens and Parks particularly at tourist places and development of new parks and gardens. Secondly promoting commercial Floriculture as a viable source of employment and livelihood. With this vision, Department of Floriculture is striving to achieve the goal.

- ➤ Enhancing tourist influx by increasing time span of tourist season and exploration of new tourist destination.
- Promotion of Commercial Floriculture.

The Department of Floriculture is committed to an integrated development of Garden Tourism industry and commercial Floriculture in the UT of J&K. The details of our services/objectives, major schemes, grievances mechanism are given below:-

Objectives/Services

- i) Maintenance and Upgradation of gardens and parks to boost tourism and provide leisure time spaces to people.
- ii) Maintenance, Renovation and conservation of historic Mughal Gardens.
- iii) Development of new gardens and parks for taping different seasons and bringing all the districts on tourist map and ensure sustained tourist flow
- iv) Conservation of indigenous ornamental flora.
- v) Introduction and multiplication of elite types and varieties of new ornamental flora to broaden germplasm base.
- vi) Sale of ornamental plants to general public at minimal costs.

- vii) Efficient, Economic, Eco-Friendly and sustainable flower production, seed production and protection technologies.
- viii) Introduce scientific mode of flower production by using latest machinery for pre and post-harvest operations like field operations, manuring, fertilizing, harvesting, storage, grading, transportation etc.
- ix) Promote protected cultivation of flowers by use of poly houses, shade net houses and Polycarbonated polyhouses, dry flower trade, floristry (bouquet designing, flower arranging in different styles and decoration for stages, man daps, vehicles, banquet halls), aromatic plant cultivation, landscape gardening, nursery raising etc.
- x) Diversification from traditional crops to floriculture by sustained increase in the acreage under flower crops.
- xi) Minimize post-harvest losses; reduce wastage resulting in higher value realization to farmers.
- xii) Energy management and utilization of conventional and non-conventional energy sources in flower production and processing activities.
- xiii) Meeting international sanitary and hygiene standards and norms on products for export growth.
- xiv) Enhance access to capital, technology, effective management and support services such as credit and marketing in and outside the country
- xv) Establish linkages amongst stake holder such as farmers, industry, and research and extension mechanism

Organizational Structure

DUTIES

A - DIRECTORATE

Directorate of Floriculture is headed by Director Floriculture Kashmir. He serves as the Administrative Head of the Directorate and exercises all the Administrative, Financial and Technical powers. The promotion of Garden Tourism and Floriculture related

activities in Kashmir are planned, executed and monitored by Government of J&K through the Directorate of Floriculture Kashmir. The aims are achieved by the services provided through 10 (Ten) District Offices, 25 (twenty five) Sub-District Offices

B – DISTRICT OFFICES

District Floriculture Offices are headed by Floriculture Officers. District office is responsible to implement Floriculture development works as allotted by Head of Department, in accordance with proposals/suggestions for development of their respective jurisdiction of Districts submitted to Head of Department

C – SUB DISTRICT OFFICES

Sub District Offices are headed by Assistant Floriculture Officers (AFOs). The main duties of AFOs are maintenance and upgradation gardens and parks of their jurisdiction and prepare floral plans and develop new parks for increasing green spaces. They also disseminate the knowledge of floriculture technology to farmers. Their primary role is to aid the farmers and farming societies to make better decision to increase Floriculture production. They are the Liaison Officers between the farmers and Government, guide the farmers on how to maximize their crops yields and profits, provide guidance and demonstration on the latest technologies and impart training to advantage of such technologies

CENTRALLY SPONSORED SCHEMES

Different centrally sponsored schemes like MIDH (MISSION FOR INTEGRATED DEVELOPMENT OF HORTICULTURE), RKVY (RASHTRYA KRISHI VIKASH YOJANA) and ATMA are under implementation for promotion of commercial floriculture. The Department is organizing regular trainings within and outside the J&K for the farmers/growers in order to make them aware with modern trends in Floriculture Sector. Awareness programmes/ exposure visits are being organized by the department to attract more and more farmers towards this sector. An area of 71.4 Ha is presently under floriculture trade with 15.72 Ha under protected cultivation for cut flower production, 10.91 Ha under ornamental nurseries and 39.92 Ha under aromatic plants cultivation. The production of cut spikes under roses, carnation, gerbera, Lilium and gladioli has increased manifold. At present 2154 growers/farmers are registered with Department of Floriculture out of which 349 are active in the sector and are yielding good returns from the trade. The growers have generated revenue of 12.51 crores from floriculture trade. Department is providing technical guidance and financial assistance to flower growers for promotion of commercial floriculture.

Activities/Programmes under CSS:

- i) Protected Cultivation of Cut Flowers like roses, carnation, gerbera, Lilium and gladioli
- ii) Establishment of ornamental Nurseries.
- iii) Area Expansion of Flowers cultivated in open like Marigold, cosmos etc.
- iv) Creation of Water Sources

- v) Cultivation of Aromatic plants like Lavender, Rosemary and Scented Geranium
- vi) Establishment of Vermi compost Pits
- vii) Human Resource Development by way of Training/exposure visits in and outside J&K
