


Terms and Conditions: -

1. Bids must be accompanied with cost of tender document (Non-Refundable) in shape of **e-Challan, copy of receipt from Treasury** favouring to Accounts Officer, Department of Floriculture (G&P) Kashmir (Tender inviting authority) indicating name of job/work by crediting the requisite charges to the **MH-0406-Receipt of Forestry & Wild Life, Misc. Revenue (Public Gardens). SMSE/SSI units if cost of CDR's relaxes or exempted must upload the representation the I/we are qualifying for released amount of CDR or exempted from deposits or uploading of CDR.**
2. Rate should be quoted as per Cft. inclusive of all the Taxes & duties indicated in concerned BOQ.
3. **After end submission date, the participated bidders/contractors/suppliers are requested to submit original documents for establishing genuineness and validity.**
4. The tenderers/Suppliers should upload following essential documents otherwise tender shall be out rightly rejected: -
 - a. Registration with any Government/Semi Government Department.
 - b. PAN card.
 - c. GSTIN Registration.
 - d. Copy of e-Challan
 - e. Adhaar Card.
 - f. Certificate of Bidder as per Annexure 'A'
5. The supplies shall be received by the concerned order placing authority (Floriculture Officer concerned) strictly in accordance with the quality/specifications as per terms and conditions of the concerned e-NIT/Supply Order.
6. The purchase of Manure should restrict strict to the allotted quantity/ availability of funds only without creating any liability.
7. Any CDR/FDR pending in the Department will not be accepted towards the current e-NIT.

Successful Bidder/firm shall have to enter into formal Agreement Deed with the Department on non-judicial stamp paper and in case of failure in executing the agreement, failure on doing so shall not debar the concerned Supplier from the legal binding of the e-NIT. Besides, the CDR shall not be released.
10. The supplies full or part there of not up to specification shall be rejected out rightly and the same shall be replaced by the supplier without charging any additional cost.

11. The time mentioned in the Supply order placed by the Floriculture officer is the essence of the contract.
12. For any dispute arising out during the currency of contract, decision of the Divisional Level Purchase committee shall be binding and final.
