

- 4.4 All the original documents should be produced at the time of scrutiny, if asked for by the technical evaluation committee.
- 4.5 Registered Plant Material Growers/Plant Material Producers/Plant Material Traders/Plant Material Importers/Reputed Nurseryman having valid Import-Export Registration are eligible for tendering.
- 4.6 No conditional tender will be accepted/entertained.
- 4.7 The tenders without tender fee shall be out rightly rejected.
- 4.8 No technical/financial bid shall be accepted in hard copy.

Bidder Instruction /Eligibility: -**7. Award of Contract: -**

- a. The contract shall be awarded to the bidder whose bid has been determined to be lowest.
- b. The successful bidder/firm(s) shall have to draw necessary agreement with the Department within a weeks' time from the date of issuance of the Contract and shall be required to submit signed copy of **Undertaking (Annexure C) as well.**

8. Delivery: -

- a. The time of delivery is the essence of the contract. Any delay without reasonable ground on part of the supplier may attract penalty.
- b. Within 24 hours of dispatch of supplies from Foreign Origin the supplier shall notify the purchaser the complete details of dispatch and also supply documents by Registered Post/Courier and copy thereof by e-mail.
- c. The supplier shall have to submit Temperature and Humidity Sensor placed with the consignment during entire transit period from Origin Country to India, UT of Jammu & Kashmir, and Tulip Garden Srinagar at the time of delivery of the supply.
- d. Packing Germ plasm should be packed in non-organic sterile material to meet the plant quarantine standards of Govt. of India. The shipment should be made through best and safe transport mode. The requisite temperature and the moisture should be maintained in the packing. The supplier shall provide such packing of the planting material as is required to prevent their damage or deterioration during transit to their final destination as indicated in the supply order and scope of work.
- e. The Plants must be properly packed, tagged and dispatched.
- f. The Plants must be true to type with certificate of gaminess from the source (exporting agency/growers).
- g. Individual plants need to be labelled for variety.
- h. The stock will have to be supplied in dormant conditions and without signs of sprouting.
- i. The contractor or his representative should be present at the time of delivery of the material at Tulip Garden, Srinagar.

9. Payments: -


- a. **80%** payment shall be released on receipt of supply/consignment as per specification provided in supply order and balance amount of **20%** retained in the shape of performance guarantee after observing the satisfactory performance, etc. of supplied material by the concerned Floriculture Officer and as per funds available.
- b. All applicable and prevailing taxes will be recovered from the Supplier bill as per government orders.
- c. Supplier/firm shall have to furnish Phytosanitary/Quarantine Certificate for each imported consignment duly issued by the concerned Government authority of the origin.
- d. Supply shall be subject to verification in respect of apparent disease or any other disorder by the Designated Inspection Authority, HOD Plant Pathology, SKUAST Kashmir and Tulip committee constituted vide Floriculture Order No.342/Est of 2023 Dated.16.06.2023 issued under endorsement No. DOFK-GS0Miss/1/2023/233486 dated.16.06.2023. Material not conforming to the tender specifications shall out rightly be rejected on the cost and risk of the supplier.
- e. The rejected and substandard material should be removed from the site of work immediately and the Department shall not be responsible for any damage/loss of rejected material, if the same will


not be removed within five days, then the same will be removed by the department at the cost to be borne by the bidder.

10. Financial Bid:

- a. Financial Bid will be opened online on the specified date & time.
 - b. The financial bids of only technically qualified bidders will be opened on the stipulated date & time.
 - c. Rates for Germ plasm should be quoted in (IN) Indian rupee FOR Tulip Garden, Cheshmashahi, Srinagar UT of Jammu & Kashmir (India) inclusive of all the applicable taxes, duties, levy, Transportation/freight/loading/unloading transit insurance and any other requirement incurred up to Tulip Garden.
 - d. All charges up to Tulip Garden are to be borne by the Supplier.
 - e. Tax deduction at source as applicable shall be made from the payments due to the successful bidder.
 - f. The bidder/firm shall indicate the variety wise availability of material.
 - g. Selection of Germplasm out of advertised varieties will be made after receiving and opening of tenders.
11. Purchase Committee reserves the right to accept or reject any or all tenders without assigning any reason thereof.
 12. In case of dispute, if any, arising during the currency of contract, the decision of the Divisional Level Purchase Committee of Directorate of Floriculture Kashmir framed vide Govt. Order No.12-JK (Flori) of 2022 Dated. 18.10.2022 shall be final and binding.
 13. Any dispute arising out of or in connection with this contract including any question regarding the existence, validity or termination shall be referred to and finally resolved by arbitration in accordance with the Jammu & Kashmir International Arbitration Centre (Arbitration Proceedings). Rules for the time being in force (JKIAC Rules) which rules are deemed to be incorporated by reference in this clause.
 14. The seat of the arbitration shall be Srinagar where the parties wish to seat the arbitration.
 15. The arbitration tribunal shall consist of three number of arbitrators, one to be appointed/nominated by each party and those 02 appointed arbitrators shall choose another arbitrator for conducting arbitration proceedings under the Jammu & Kashmir International arbitration centre (arbitration proceedings) rules.
 16. Language of the arbitration shall be English in which the parties intend to conduct the arbitral proceedings.
 17. The law governing the contract shall be Union Territory Law, the law of which the parties intend to apply.
 18. The competent courts of Union Territory of Jammu and Kashmir shall have exclusive jurisdiction over any dispute arising between the parties.


