Terms and conditions: -


01. Bids must be accompanied with cost of tender document in shape of **e-challan/copy of receipt from Treasury** favouring to Accounts Officer, Department of Floriculture Kashmir (Tender inviting authority) Indicating name of job/work by crediting the requisite charges to the MH-0406-Receipt of Forestry & Wild life, Misc. Revenue (Public Gardens) and earnest money/Value of Security deposit in the shape of CDR/FDR pledged to Accounts Officer, Department of Floriculture Kashmir.
02. **The Successful bidder has to deposit below mentioned amount:**
 - a) **Bid amount in single installment.**
 - b) **Taxes collected at source.**
 - i) **Income tax @2% of the bid amount**
 - ii) **GST @18% of the bid amount**
03. **Security Deposit money exceeding 2% shall be adjusted towards the bid amount of the successful bidder.**
04. MSME/SSI units exempted from deposition of CDR/lump sum amount of CDR to be deposited must upload the representation that since I/We are qualifying for exemption from depositing CDR/lump sum amount of CDR.
05. **Execution of an agreement with the Department as per enclosed format, so that the Rate Contract is fixed accordingly.**
06. On-line ticketing facility.
07. Conditional Tender shall not be accepted/entertained.
08. The rates of entry tickets are as under: -

a). Adult	Rs.59.00 per head (Fifty-nine only inclusive of GST)
b).Children up to 12 years of age	Rs.24.00 per head (Twenty-four only inclusive of GST)
09. For Specially abled persons/Orphan schools/Govt. Schools/Institutions/Organizations /Agencies, entry will be free on the production of authorization from the Department.
10. The garden shall remain open from sunrise to sunset on all days during the period of contract.
11. Period of contract will be from the date of opening the garden to the visitors upto the official date of closing.
12. Bids of the tenderers who are defaulters with the Department/Government shall not be accepted.
13. The successful highest bidder shall have to deposit the bid amount in one installment along with the applicable taxes i.e. Income tax @2% and GST @ 18% within one week of acceptance of bid, failing which department will be at liberty to make alternative arrangement at the cost/risk and responsibility of the defaulter.

14. Successful bidder has to enter into formal agreement with the department on non-judicial paper for acceptance of the relevant terms & conditions of tender and contract order.
15. The contract awarded can neither be transferred nor sub-let and in case of violation, the contract shall be liable for termination at the cost and risk of the bidder.
16. The successful bidder shall be responsible for any loss or damage to the garden or its assets during the currency of contract, which may occur due to his/her negligence or due to negligence of his deployed staff.
17. Items like liquor, cigarettes, arms, weapons, non-biodegradable items, polythene, Food items etc. will not be allowed into the garden. Pets also will not be allowed into the garden. Successful bidder and his/her staff will be responsible for such monitoring.
18. The successful bidder shall not allow any movable or immovable (Rehari, Khokha, vendors, Hawkers etc.) into the garden. Any complaint/violation will attract termination of contract on the cost and risk of the contractor besides forfeiture of CDR/FDR.
19. The successful bidder shall have to engage disciplined and uniformed manpower to operate entire process of ticketing, entry monitoring and cleanliness in the vicinity of ticket booths during the entire period of contract.
20. The successful bidder shall not have less than (10) persons to operate the process of entry ticketing.
21. The ticketing employees deployed by the successful bidder shall to wear the identity card issued by the Floriculture Officer, Concerned.
22. The tenderers/firms have to upload following essential documents, failing which the tender shall be out rightly rejected:
 - a) Registration/Govt. approved dealership Certificate
 - b) Pan Card
 - c) The bidders shall have to valid registration for TAN/GST Registration
 - d) Proof of having filed the returns of Income Tax/GST for the last 03 years.
 - e) Relevant CDR for an amount of **Rs.8,41,400.00.**
 - f) Copy of e-challan for **Rs.2000.00 (Rupees Two Thousand only)**
 - g) Adhaar Card
 - h) Bidder Certificate as per (Annexure A).
23. The successful bidder shall have to ensure close liaison with the staff of Floriculture Department working in the garden. However, there will be no entry fee for the employees of the Department of Floriculture, State/Central Government guests and labourers engaged for any development work inside the garden, on production of identity card.
24. The Department shall not be responsible for any monetary loss suffered by the contractor due to declaration of strikes/curfew/VVIP/VIP movements or any other un-foreseen reasons whatsoever. During the contract period, the maintenance of entry ticket booths/area, watch and ward, shall be the sole responsibility of the successful bidder. In case of any default/complaint received, the department shall be at liberty to make good the loss or get the job executed as the case may be, at the cost & risk of contractor.

25. Bids/offers below the reserve bid shall not be entertained and CDR's of such bidders will be forfeited and same money remitted in treasury.
26. The request for release of un-casted CDR's shall not be accepted by the Department.
27. Bid accepting committee reserves the right to accept or reject any tender without assigning any reason thereof.
28. In case of dispute, if any, arising during the currency of contract, the decision of the Divisional Level Purchase Committee of Directorate of Floriculture Kashmir shall be final and binding.
